Adam has been living with HIV since 2017. He is a member of the Positive Speakers Bureau, a facilitator of HIV related peer support groups and recently became a director of Living Positive Victoria.

Professor Bruce Brew



Bruce Brew is Professor of Medicine (Neurology) University of New South Wales and University of Notre Dame, Director of the Peter Duncan Neurosciences Unit St Vincent's Centre for Applied Medical Research and neurologist at St Vincent's Hospital Sydney. He graduated in Medicine from the University of Sydney (MBBS Hons) and holds two higher degree doctorates – Doctorate of Medical Sciences from the University of Sydney and a Doctorate of Science from the University of New South Wales. He has a longstanding interest in HIV neuropathogenesis particularly in relation to cognitive impairment at both clinical and basic science levels, and HIV related neurological complications in general. He has designed and participated in numerous clinical studies related to HIV brain disease and written over 400 papers and four books with approximately 35,000 citations (Google Scholar). He has served on the editorial boards of several journals, including AIDS, Lancet HIV and several societies including the International Society for Neurovirology. He was on the scientific committee for CROI for several years and continues to serve on the scientific committee for HIV and Ageing. In 2015, he was awarded the Order of Australia for his services to Neurology. In 2018, he was elected President of the International Society for Neurovirology, and served in this position till 2024.

Dr Christina Chang



Christina is an Infectious Diseases physician-scientist, and is internationally recognised for her clinical and research expertise in cryptococcal meningitis (CM) and cryptococcosis-associated immune reconstitution inflammatory syndrome (C-IRIS).

Dr Vincent Cornelisse



Vincent is a sexual health physician. His research focuses on sexual health epidemiology and public health interventions to reduce transmission of HIV and other sexually transmissible infections. He was the principal author of ASHM's 2024 consensus statement on Doxy-PEP.

A/Professor Simon Crouch



Associate Professor Simon Crouch is a Public Health Physician at the South East Public Health Unit with an adjunct appointment with the School of Public Health and Preventive Medicine at Monash University. He has had a varied public health career, but now focuses on communicable disease prevention and control. During the recent COVID-19 pandemic, A/Prof. Crouch served as Deputy Chief Health Officer at the Victorian Department of Health. A/Prof. Crouch has a particular interest in public health emergency management and has a Public Health Emergency Management Fellowship from the US Centers for Disease Control and Prevention. A/Prof. Crouch is very active in the Australasian Faculty of Public Health Medicine and is currently the Regional Education Coordinator for Advanced Training and the Deputy Lead Examiner for the Faculty.

Ms Alison Duncan



Alison is a senior clinical pharmacist who has worked at The Alfred Hospital for more than 20 years. Alison's passionate interest is Infectious Diseases, in particular infections in the immunocompromised host, opportunistic infections and HIV. Alison leads the HIV team at Alfred Health (encompassing the Alfred and Melbourne Sexual Health Centre), working closely with ID physicians and nursing staff in both the inpatient and ambulatory outpatient settings. Her favourite things are solving complex drug queries (especially drug interactions) and helping patients understand their medicines. Alison is actively involved in teaching and training; participating in the education of undergraduates, pharmacists (including mentoring an advanced training resident in infectious diseases) and other health professionals. Alison and her Alfred colleagues established the HIV pharmacists special interest group, which meets virtually a few times each year. She and her team have presented their work both nationally and internationally.

Heather Ellis was diagnosed with HIV in 1995 after riding her motorcycle solo through Africa. She is the communications and engagement coordinator with Positive Women Victoria, an HIV communications specialist, a member of the HIV Cure Consortium, the Network of Women Living with HIV and INFORM+, an international group of researchers, clinicians, and community advocating for wider acceptance of breastfeeding for mothers with HIV. Heather is passionate about translating complicated HIV science into plain language for the HIV community. A 60-year-old single mother of three boys, Heather believes improving quality of life for people with HIV is a holistic approach based on ARV treatments, clinical care and screening, nutrition, exercise, social interaction and peer support. Dr Beng Eu



Dr Beng Eu is a GP and co-director of Prahran Market Clinic and a Senior Fellow (honorary) at the Department of General practice, University of Melbourne. Mr Robert Grant





Professor Jenny Hoy



Professor Jenny Hoy is an Infectious Diseases physician and Director of HIV Medicine at Alfred Health and Monash University. She has been involved in HIV patient care and research since 1988, particularly research to aid the understanding of the prevention and management of comorbidities associated with Ageing and HIV. She is actively engaged in HIV education, was a member of the Australian Antiretroviral Guidelines Panel for 22 years before joining the IAS-USA Antiretroviral Guidelines panel in 2012. She is passionate about quality of care for people with HIV and quality of life experienced by people with HIV.

A/Professor Peter Hunter



Peter Hunter is a senior geriatrician and physician, the Director of Geriatric Medicine and the Clinical Program Director of Home, Acute and Community at Alfred Health. He is an Adjunct Clinical Professor at the School of Translation Research at Monash University. Peter has over 35 years' experience as a clinician. Peter has been involved with the development of a number of initiatives and polices with the Victorian Department of Human Services including the Hospital Admission Risk Program, HealthLinks and The Better at Home Advisory Committee. Peter was the Deputy Chair of Implementation taskforce for the Voluntary Assisted Dying Legislation. Peter was the inaugural clinical lead for the care of Older People in Safer Care Victoria and played a key role in improving care of older people, including in residential care during the COVID-19 pandemic in 2020 and 2021. Currently, Peter maintains an active clinical role as a geriatrician and is responsible for managing a range of acute, sub-acute and community services across Alfred Health. Vikas has run test cases on Migration Law before the Full Federal Court of Australia and the High Court. In addition, he has assisted asylum seekers at the Manus Island Detention Centre in Papua New Guinea with their claims for protection. Outside Migration law, Vikas has published articles, co-authored and edited publications on HIV and the Law (including a chapter in the Law Handbook), and presented and authored abstracts at national and international conferences. He has presented at government forums on amendments to the My Health Records Act and appeared and made submissions on HIV criminalisation before the NSW and Queensland Law Reform Commissions. Dr Matt Penn




